*Please note: Preschool is billed separately from elementary school and is not part of the Family Tuition Rate. Your preschool tuition is tax deductible and full-time preschoolers will automatically receive a \$500 grant for Kindergarten and First Grade.

3) \$100 non-refundable Registration Fee

4) Birth Certificate (Children must be 3 by August 1 and potty trained!)

Before school starts on August 14, we will need a copy of up-to-date immunization records.
